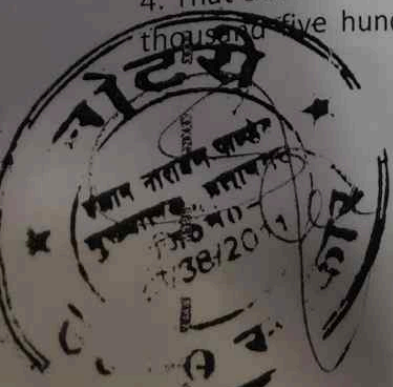

programme which 4022.00m² (four thousand twenty two square meters) shall be the built up area and the remaining space for lawns, playfields etc.

5. That the land is exclusively meant for running the education institution. The entire land earmarked for the purpose of running the desired course is duly registered in the name of the Institution through the Society/Trust running the Institution.

6. In connection with the application for grant of affiliation of B.ed Course with 100 Students the applicant hereby undertakes to comply with the following: -

(i) That the Management has seen studied and understood the norms and conditions stipulated by the NCTE for grant of recognition and those of State Government for grant of affiliation to the programme proposed. If the State Government or a body or a person authorized by it, at the time of inspection, finds any deviation from the prescribed norms/standards, we will accept any unfavorable decision resulting thereof.

(ii) That infrastructural, instructional and other facilities will be provided as per the NCTE/State Government norms, standards and guidelines prescribed from time to time.

(iii) That admission of students, satisfying the eligibility conditions will be made as per the State Government policy.

(iv) That there shall be reservation of seats for SC/ST/OBC/handicapped etc. as per the Policy of State Government.

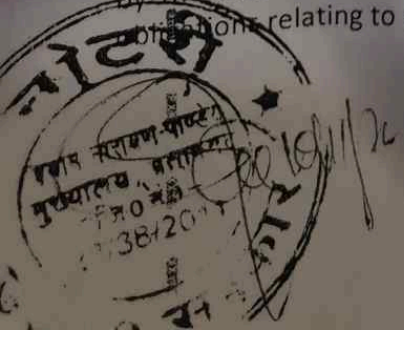
(v) That admission to the Course will be made only after the affiliation is granted by the State Government.

(vi) That the supporting and other staff will be appointed as per the guidelines of the State Government.

(vii) That the tuition and other fees will be charged at rates prescribed by the State Government and shall not charge donations, capitation fees, etc. from the students.

(viii) That the academic and other staff of the institution shall be paid such salary as may be prescribed by the State Government from time to time.

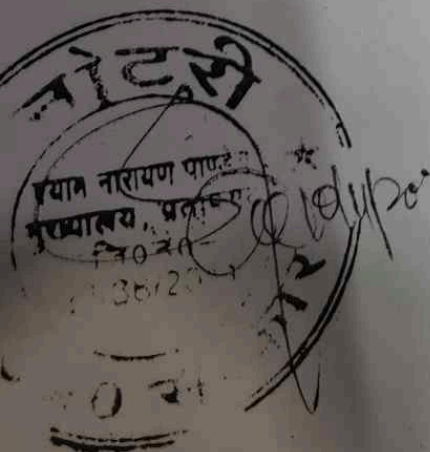
(ix) That the Management shall discharge the statutory obligations relating to provident fund, pension, gratuity etc. in respect of all its employees.

- (x) That the Management will make adequate funds available for providing satisfactory facilities and for proper programme implementation.
- (xi) That the accounts of the institution will be properly maintained and annually by the audit authorities or a Chartered Accountant, and will be open for inspection.
- (xii) That the Management will strictly follow all conditions and norms prescribed by NCTE / State Government from time to time, conduct the programme in all earnestness, and submit itself to inspection by the State Government or a body or a person authorized by it as required at any time.
- (xiii) That the institution will provide a conducive atmosphere for academic and extracurricular activities and will prevent any mental and physical harassment of teachers and trainees.
- (xiv) In the event of non-compliance by the Sarita Education Society Society/Trust with regard to the norms and standards and any other condition laid down/prescribed by the State Government from time to time. The State Government or a body or a person authorized by it will be free to inspect at any time and take all necessary measures for effecting withdrawal of its recognition for permission, without consideration of any other issue, and that all liabilities arising out of such a withdrawal would solely be that of the Institution/Management.
- (xv) That the Management will not cause or allow discontinuation of the Course in any year or for any batch, and that where compelled, it will seek the concurrence of NCTE/State Government for discontinuation on the completion of the year/batch.
- (xvi) That the course for which the affiliation is applied for is solely on self-financed basis and we shall not claim any financial grant or assistance from the State Government. I do hereby swear that my declaration under Para's (i) to (xvi) are true and correct and that it conceals nothing and that no part of this is false. In case the contents of affidavit are found to be incorrect or false, I shall be liable for action under the relevant provision of the Indian penal code and other relevant laws
